THE PROCEDURE IS VALID FOR INDIVIDUAL AND GROUP TICKETS AS WELL FOR NOT-TICKETED GROUP BOOKINGS AND FOR ALL MARKETS FOLIALLY

TICKETS MUST BE ISSUED ON/BEFORE THE DAY THAT ENTRY RESTRICTIONS WERE PUBLISHED ON IATA SITE OR GROUP CANCELLATION MUST BE DONE ON/AFTER THE DAY THAT ENTRY RESTRICTIONS WERE PUBLISHED ON IATA SITE.

## FE INVOL REF DUE TO QUARANTINE COVID

#### INVOLUNTARY REROUTING

REROUTING IS NOT PERMITTED

IF THE PASSENGER IS NOT ALLOWED TO ENTER THE COUNTRY OF DESTINATION DUE TO THE FACT THAT INFORMATION REGARDING HIS LAST STAY WITHIN 14 DAYS WERE INTENTIONALLY HIDDEN AND/OR THE PASSENGER WILL HAVE TO RETURN IMMEDIATELY TO THE POINT OF ORIGIN, PLL LOT RESERVES THE RIGHT TO CHARGE THE PASSENGER FOR THE COST OF CARRIAGE TO THE DEPARTURE POINT.

SALES RESTRICTION: ON/BEFORE 31MAR20

**TRAVEL DATES RESTRICTION: 12MAR20-24APR20** 

**REBOOKING FREE OF CHARGE: UNTIL 31DEC20** 

PERMITED ONE FREE OF CHARGE REBOOKING ON LO OPERATING FLIGHTS WITHIN THE SAME FARE FOR DATES NO LATER THAN **31DEC20**. THE WHOLE JOURNEY MUST BE COMPLETED TILL **31DEC20**.
