# Notice on Extra Flight from Moscow to Tokyo

Although operation of international flights is restricted by the Russian government, JAL has applied to the aviation authorities of Russia and Japan to operate an extra flight to accommodate the growing demand for the Japanese people to return to Japan and non-Japanese who are authorized to depart Russia and to enter Japan. We hereby wish to announce that we are planning to sell tickets for the following flight subject to government approval.

Revised points from the 4MAY version is written in blue.

## 1. Operating Schedule (Flight JL42)

Monday, 11<sup>th</sup> of May      From Moscow **Sheremetyevo (SVO)**  
Departure time 19:15 from **Terminal F**

Tuesday, 12<sup>th</sup> of May      To Tokyo Haneda (HND)  
Arrival time 10:35 at Terminal 3

\* Another flight departing on 13MAY is being considered.

#### 4. Notes upon booking and sales

As an extra flight, there are restrictions as follows.

- This flight is available **only for Japanese nationals and non-Japanese who are allowed to enter Japan [note]**.

[Note: Non-Japanese holding the following status of residence in Japan; "Permanent Resident", "Spouse or Child of Japanese National", "Spouse or Child of Permanent Resident" and "Long Term Resident". Contact the Консульский отдел посольства Японии for details. Resident's Certificate and other documents to prove the status will be checked upon check-in at the airport.]

- Check-in time is from **16:45** until **18:15**.
- **Entrance for Terminal F is open only on the arrival floor.**
- Please purchase vouchers for excess baggage and live animals (pets) upon purchase of air tickets, as they will otherwise be unacceptable upon check-in.
- Connecting passengers from domestic flights should not check-in through to this flight. Check-in at SVO is mandatory.
- There are unavailable seats to secure social distance in the cabin. Seats for families wishing to sit next to each other will be arranged upon check-in at the airport.
- All airport lounges at SVO are closed for safety reasons.
- Only regular meals will be provided for all classes. Special meals (infant, anti-allergic etc.) cannot be provided.
- Japanese cuisine only will be available for Business Class.
- Availability of inflight sales is not confirmed.
- As this flight is subject to quarantine inspection upon arrival at Haneda, it will take more time than usual until deplaning. We ask you to comply with the instructions from the quarantine officer at HND and submit the required documents to be filled out in the cabin (available during the flight).
- Please check Aeroexpress schedule being reduced if in use.
