GUIDELINES ON ISSUANCE OF TRAVEL DOCUMENTS FOR S7 MULTI PASS FARE PRODUCT OF S7 AIRLINES

1. GENERAL PROVISIONS

- 1.1. These Guidelines replaces the "Guidelines on issuance of travel documents for S7 multi pass fare product of S7 Airlines" of 20th of March 2014 which shall terminate immediately after signing of this document.
- 1.2. These Guidelines set forth the procedure for issuance of travel documents for the S7 multi pass fare product of S7 Airlines.
- 1.3. S7 multi pass is the fare product of S7 Airlines designed for purchase of a single ticket for several round trip carriages (Round Trip—RT).
- 1.4. The carriage for the S7 multi pass fare product is allowed only for own regular flights of S7 Airlines (hereinafter referred to as the Carrier) and codeshare flights operated by OOO Globus (GH Operator). Ticket issuance is prohibited for the codeshare flights (range S74000—S74999) where S7 Airlines is a marketing carrier.

2. FARE APPLICATION RULES FOR S7 MULTI PASS PRODUCT

- 2.1. S7 multi pass fares are published in the computerized reservation systems.
- 2.2. Business service class, J reservation code.
- 2.3. Ticket issuance at S7 multi pass fares is allowed for 4 or 8 flight segments. Ticket issuance at the S7 multi pass fare with a different number of fight segments is PROHIBITED. It is permitted to include land segments into the ticket. Examples of possible routes:
 - for 4 flight segments:

MOW – LED – MOW – LED – MOW

KZN – MOW – LED – MOW – KZN

MOW – AER – MOW – OVB – MOW

MOW – UFA – MOW – KZN // UFA – MOW
```

for 8 flight segments:

```
MOW – PEE – MOW – PEE – MOW – PEE – MOW – PEE – MOW

MOW – KJA – MOW – KJA – MOW – TOF – MOW – TOF – MOW

MOW – AER – MOW – OVB – MOW – AER – MOW – OVB – MOW

MOW – AER – MOW – LED – MOW – IKT – MOW – OVB – MOW

KZN – MOW – LED – MOW – AER – MOW – KUF – MOW – KZN

MOW – OVB – IKT – VVO – IKT – OVB – MOW – OMS – MOW

MOW – KZN – MOW – KZN – MOW // KZN – MOW – UFA // KZN – MOW – UFA
```

- 2.4. The fares under S7 multi pass programme have been introduced between pairs of cities for domestic flights inside Russia and are divided into areas (Appendix 1):
 - PROMO area area code PR

- area 1 —area code 1
 area 2 —area code 2
 area 3 —area code 3
- 2.5. Fare type:
 - for a carriage with 4 flight segments—J*PASS4;
 - for a carriage with 8 flight segments—J*PASS8, where: * is the area code.
- 2.6. Fare levels have been introduced in accordance with each area:
 - for PROMO area: JPRPASS4/JPRPASS8/ J1PASS4/J1PASS8/ J2PASS4/J2PASS8/ J3PASS4/J3PASS8;
 - for area 1: J1PASS4/J1PASS8/ J2PASS4/J2PASS8/ J3PASS4/J3PASS8;
 - for area 2: J2PASS4/J2PASS8/ J3PASS4/J3PASS8;
 - for area 3: J3PASS4/J3PASS8
- 2.7. The following fare combinations are possible:
 - JPRPASS4 fares may be combined with JPRPASS4 fares only, JPRPASS8 fares may be combined with JPRPASS8 fares only;
 - J1PASS4 fares may be combined with J1PASS4 fares only, J1PASS8 fares may be combined with J1PASS8 fares only;
 - J2PASS4 fares may be combined with J2PASS4 fares only, J2PASS8 fares may be combined with J2PASS8 fares only; and
 - J3PASS4 fares may be combined with J3PASS4 fares only, J3PASS8 fares may be combined with J3PASS8 fares only.
- 2.8. At the time of ticket issuance, the first flight segment shall be issued with a confirmed reservation for a specific flight/departure date, other flight segments, at the Passenger's option, may be issued either for specific flights/departure dates or with an open departure date (OPEN).
- 2.9. Reservation, payment, and ticket issuance shall be performed at the same time.
- 2.10. It is prohibited to issue additional tickets with SA status (for example, additional ticketing for inactive/closed flights).
- 2.11. It is prohibited to break the sequence of flight segments.
- 2.12. Taxes and charges, including charges of airports/cities/agencies, shall not be paid. The EXEMPT format should be used to remove them from calculation.
- 2.13. Ticket validity period
 - 2.13.1. For the flight
 - for J*PASS4 MAX STAY 2 months from the departure date of the first flight coupon; and
 - for J*PASS8 MAX STAY 6 months from the departure date of the first flight coupon.



- 2.13.2. For changes in travel conditions:
- for J*PASS4 2 months (from the sale date for a fully unused ticket, from the departure date for the first flight coupon for a partially used ticket); and
- for J*PASS8 6 months (from the sale date for a fully unused ticket, from the departure date for the first flight coupon for a partially used ticket).
- 2.13.3. For refunding:
- 1 year (from the sale date for a fully unused ticket, from the departure date for the first flight coupon for a partially used ticket).
- 2.14. The travel conditions (date/flight/route) may be changed any number of times, before and after the travel beginning without imposing any charges or surcharges on the passenger.
 - It is prohibited to change the carriage route if the new flight is included into a higher area.
 - The carriage route may be changed if the new flight is included into a lower area. New ticket must contain original ticket data (fare basis, fare amount, fare calculation ladder). The passenger shall not be refunded for the charging difference.
- 2.15. Ticket refunding:
 - For refund of a fully unused ticket, the amount paid for the carriage shall be refunded with deduction of the refunding charge.
 - For refund of a partially used ticket, the difference between the amount paid and the cost of
 the actually performed carriage shall be refunded; the cost shall be calculated at the
 published regular business class JFLOW/JFLRT fares with deduction of the refunding charge.
- 2.16. Miles under the S7 Priority programme shall be charged in accordance with conditions applicable to the regular business class FLEX fares.

3. TICKET ISSUANCE UNDER S7 MULTI PASS PROGRAMME

3.1. The fares under the S7 multi pass programme are available in the screens of published fares. The standard request format shall be used. For example, the request format in Gabriel CRS:

- 3.1.1. The fare type shall be selected in accordance with the Table of Areas set out in Appendix 1.
- 3.1.2. If the carriage consists of flight segments within one area, select the fare type with the code of the relevant Area.
- 3.1.3. If the carriage consists of flight segments within different areas, select the fare type with the code of the greatest Area.
- 3.2. The code of the relevant fare and the indicator for removal of taxes and charges shall be specified in the request when the fare is calculated automatically. Calculation formats:
 - For Gabriel CRS:

FQT:*J2PASS4#E*E----

FQT:*J2PASS4//:RUB#E*E---- calculation for travel to/from Simferopol

For Amadeus:

FXP/L-J2PASS4/R,U,WT

For Galileo:

FQTE/@J2PASS4

For Sabre:

WPQJ2PASS4¥TE«

For Sirena Travel:

TB manual calculation

BB5 choose an option, where 5 is an option number

Note! Manual calculation with taxes will be applied.
