When Creating an Electronic Ticket Mask

TO: AGENTS OF S7 AIRLINES

Dear Colleagues,

Due to many errors in Automatic Generating Report System (ARGS) caused by incorrect transportation documents data, please, be informed about the necessity to strictly comply with the format of completing the FARE CALC line in ticket sale and reissue masks.

We would like to remind you that according to the Information Letter 10-209-12-15/000020 on Manual Pricing Prohibition When Automated Pricing Is Available as of March 05, 2015, issuing tickets using semi-automated or manual masks is only permitted in the below situations:

- System errors, when automatic pricing is not available for any reasons. In this situation the Agent must inform the Carrier via e-mail <a href="tech@s7.ru">tech@s7.ru</a> and attach the information (screen shot) about the error.
- Issuing tickets in a group booking when automatic pricing is not available. E.g. when the time-limit for the confirmed RBD has expired or when issuing tickets using saved fares.
- Issuing tickets under Procedures and Instructions that require manual or semi-automated ticket masks.

If you require manual pricing, the following conditions must be met:

- FARE CALC line must be filled in.
- The FARE CALC line must include:
  - o Full itinerary with city codes, transfer indicators, surface sectors, etc.;
  - Carrier's code on every segment;
  - Cost of each flight segment and total fare amount in the fare construction currency (NUC for international transportation, RUB for travel within Russia);
  - o Additional surcharges, surcharges Q/S, as provided for by fare rules, if any;
  - End of calculation indicator END and rate of currency exchange ROE for international travel.
